 - 3 expiration of time-limited rental assistance benefits operated by a program located in Vermont (examples: Vermont Emergency Rental Assistance Program, Rapid Rehousing, Etc.); or
 - 4 any other evidence of risk, as determined by the PHA

3. Move-Up preference:

This Preference is available to families with incomes above 30% Area Median Income (AMI) up to 50% AMI who meet the following criteria:

- actively receiving rental assistance benefits through a VSHA-administered rental assistance program; **and**
- family is certified to be in compliance with benefit program & tenancy requirements
